- 1.** Call Legal Aid Line at: 1-888-534-1432. The Intake line is open Monday through Friday from 9 am and 4 pm. Carefully input your phone number, including area code. You will receive a call back by 5 pm the same day.
- 2.** Begin an application online at **[www.legalaidline.org](http://www.legalaidline.org)**. The online application is open 24 hours/day, 7 days/week. You will be called back by an Intake Specialist within 48 to 72 hours after submitting the online application.
- 3.** Walk into any LAWO office between 9 am - 4:30 pm. You will be connected to an Intake Specialist.
